Waiting for repayment can be almost as stressful as having a special needs child. I'ts very hard to put out example/ 300\$ out 9f pocket and not be repaid at a specific time and have to wait and pray the check comes of pocket

We need a respite facility in Delaware for people with intellectual disabilities and senior citizens

Services for relatives keeping together and taking care of sibling units due to parental abuse or drugs or social services, especially grandparents

my son doesn't use respite as much now, but it was a huge need and issue when he was younger (and up to age 14ish). There are no private providers around here. Luckily we had family that would help but for those that don't, I don't know how they survive. Not just anyone can watch our kids. We need providers with training and heart. And we do need a break from caregiving! Respite shouldn't be so difficult. And then we met other parents along the way who didn't even know respite was a thing!

Respite services are so needed! Friends and family do try to help but we'd be able to do more with skilled respite providers caring for our child.

Everything has been covered in this survey.

My son is nonverbal, so I would ideally prefer the respite to have two adults present at all times; unfortunately, in the past eight years, I couldn't find even a single person to provide respite locally. (Camp Fairlee Manor was my lifeline and the only respite provider who would accept my son.)
