### **MEDICAID PEDIATRIC RESPITE SERVICES**

**DELAWARE HEALTH AND SOCIAL SERVICES, DIVISION OF MEDICAID AND MEDICAL ASSISTANCE (DMMA) IS HOSTING ADDITIONAL VIRTUAL INFORMATION SESSIONS TO PROVIDE INFORMATION AND UPDATES ON THE NEW MEDICAID PEDIATRIC RESPITE SERVICE.**

As you may know, effective January 1, 2023, the Delaware Health and Social Services (DHSS), through the Medicaid program, began providing respite services for eligible children and adolescents up to age 21, including individuals with Autism Spectrum Disorder (ASD).

Respite services are defined as services provided on a short-term basis to allow temporary relief from caretaking duties for a child's primary unpaid caregiver, parent, court-appointed guardian, or foster parent. Respite services may be available up to 24 hours a day, any time, and up to 7 days a week and may include support in the home, after school, or at night as well as transportation to and from school, medical appointments, or other community-based activities, or any combination of the above. The types of respite services available are In-Home Unskilled Respite, In-Home Skilled Respite, Out of Home Respite, and Emergency Respite.
